**REF: Adjustment in Certificate of Origin Charges** 

We trust this communication finds you well.

The Kenya National Chamber of Commerce and Industry (KNCCI) remains committed to delivering secure, efficient, and internationally compliant trade facilitation services. In line with this commitment, we wish to inform you that, effective 1st August 2025, there will be an adjustment in the charges for the issuance and endorsement of Certificates of Origin (COO).

This adjustment is necessary to sustain the high standards of service delivery and ensure the long-term reliability of our systems. The revised fee structure is outlined below:
