PUBLIC ORDER NO. 2 OF 2020 ON THE CORONAVIRUS PANDEMIC

RESTRICTION OF MOVEMENT ORDER

WHEREAS, the Coronavirus disease continues to manifest intensely within our Borders.

WHEREAS, the Cabinet Secretary for Health *vide* Gazette Notice No. 2787 of 2020 declared Coronavirus disease a **Notifiable Disease**.

WHEREAS, the Ministry of Health had pursuant to Section 36 of the Public Health Act additionally declared the coronavirus disease a **Formidable Epidemic Disease** *vide* Legal Notice 37 of 2020.

WHEREAS, the **Eastleigh Area** within Nairobi Metropolitan Area and the **Old Town Area**, Mombasa County within the Kenyan Coastal strip have recorded a surge in the number of positive coronavirus cases.



NOW THEREFORE, Pursuant to the **Executive Order No. 1 of 2018** and **IN EXERCISE** of the powers conferred by section 8(1) of the Public Order Act, and in recognition of the threat posed to national security and public order by the spread of the COVID-19 pandemic, the Cabinet Secretary for Interior and Co-ordination of National Government makes the following Order—

I. Restriction of Movement

There shall be no movement by any person **into** or **out** of the areas designated as Zone A and Zone B as specified in paragraph II during the period set out in paragraph III except as shall be permitted, in writing, by a County Police Commander.

II. Scope of the Order

II.I Zone A: Eastleigh Area, Nairobi County within the Nairobi Metropolitan Area as described in Schedule I;

II.II Zone B: Old Town, Mombasa County within the Kenyan Coastal Strip as described in Schedule II

III. Restriction period

The Order shall come into force at **7:00 P.M** on 6th May 2020 and shall remain in force for a period **fifteen (15) days**.

IV. Exemptions

This Order shall not apply to the services, personnel or workers specified in the Schedule **III** hereto.



SCHEDULE I [ZONE A]

Eastleigh is the area stretching from General Waruinge Road (*Pumwani Maternity Roundabout*) 1st, 2nd and 3rd Avenues 17th, 18th and 19th Street.

Roadblocks will be mounted to seal-off the following **three** administrative units (locations) namely;

- a. Eastleigh North
- b. Eastleigh South
- c. Eastleigh Airbase

SCHEDULE II [ZONE B]

Mombasa Old Town is the area comprising Mombasa Sub County, Mvita constituency. It is in Mji wa Kale location and Makadara sub-locations and its boundaries are north of Fort Jesus and the following streets;

- a. To the North - Mlango wa Papa Road
- b. To the East - The Indian Ocean
- c. To the south - Makadara Road
- d. To the West - Digo Road
