Introduction

The Kenya National Chamber of Commerce and Industry (hereinafter referred to as the Chamber) is a not-for-profit autonomous, private sector institution and Membership Based Organization (BMO). It was established in 1965 after the amalgamation of the three existing Chambers of Commerce at the time, namely, the Asian, African and European Chambers mandated to protect and develop the interests of the business community. To date, the Chamber has a countrywide outreach with 47 County Chambers and has signed a Memorandum of Understanding (MOU) with the Council of Governors (CoG). The MOU seeks to promote greater trade and investment at the county level. The Chamber also works in close collaboration with the Government, stakeholders and business development organizations internationally. KNCCI is an affiliate member of the International Chamber of Commerce (ICC), the G77 Chamber of Commerce and Industry, the Pan African Chamber of Commerce and Industry (PACCI), the World Chamber Federation (WCF), the Common Market for Eastern and Southern Africa (COMESA), the East African Chamber of Commerce and Industry and Agriculture (EACCIA), and the East African Business Council (EABC), among several others. The Chamber advocates for the creation of a favorable commercial, trade and investment environment that supports enterprise expansion. The membership of KNCCI constitutes small, micro enterprises, medium and large enterprises.

The governing structure of the Chamber comprises of the National Governing Council, The Chamber President, The Chamber Vice President, Chamber Directors, Chamber Sector Committees, the Chief Executive Officer, the Chamber of Trustees, as well as other relevant governance structures that may be set from time to time to execute specific tasks.

MoUs between government to government. He encouraged the Kenyan business delegation to network and establish market linkages with their counterparts in Congo Brazzaville.




trade mission consultative breakfast meeting

Following the two- day business trade mission that took place from the 7th to the 9th July in Congo Brazzaville .The Kenya National Chamber of Commerce & Industry (KNCCI) in collaboration with the KCB Foundation and KCB Bank Kenya held a consultative meeting at the KCB Karen Leadership Centre

with KNCCI members who took part in the trade mission and those interested in the Congo Brazzaville business market. The main economic sectors in Congo Brazzaville include Oil and Gas, Agriculture, Forestry, Mining, Construction and manufacturing. The Country is rich in minerals. It has fertile arable land and favorable climate. There are various trade opportunities in the following sectors:

Agribusiness

Congo Brazzaville has fertile land and favorable climatic conditions, offering opportunities for agricultural investment.



Commodities trading, particularly the importation of sugar, cooking oils, rice, wheat flour, and maize, between Kenya and Congo Brazzaville could present viable business opportunities. Both countries have unique advantages and resources that can complement each other in the trading process.

Logistics

For exporting goods from Kenya to Congo Brazzaville, companies can utilize various transportation options, such as sea freight from Mombasa port to Pointe-Noire port or Dar es Salaam port (Tanzania) to Pointe-Noire port, or even airfreight for perishable items.

Retail/wholesale outlets - supermarkets

Venturing into Congo Brazzaville to promote Kenyan products through retail and wholesale outlets, especially supermarkets, can be a promising business opportunity. Having our local supermarkets expand into the market to promote our local brands.

Meat and meat products

There is high demand of the demand for meat products in the Congolese market, Boosting exports of the meat and meat products is a lucrative business opportunity.

Hospitals and Medical equipment supplies, cosmetic surgery centers

Medical equipment and drugs are prices in Kenya are comparatively lower compared to Congo Brazzaville therefore creating an export opportunity.

The trade mission between Kenya and Congo Brazzaville served as a crucial platform for fostering economic cooperation, identifying business opportunities, and strengthening trade relations. This

marks the beginning of potential collaborations and partnerships between businesses from both countries, with the aim of creating mutually beneficial outcomes and boosting economic growth for both countries.

Mr Gao added that "This year the expo shall be remain a combination of both virtual and physical (Online +Offline) Hybrid Expo model. The foreign exhibitors will have local representatives at their respective stands. Trade visitors at Sarit Expo Centre will have a chance to see and interact with the products physically and have real time (live) discussions with the foreign exhibitors via virtual links for business deals and negotiations."

Center for International Private Enterprise CIPE) Kenya 2023 center of Excellence Kick Off Workshop



The Center for International Private Enterprise (CIPE) launched the Kenya 2023 Center of Excellence Program with a kick-off workshop attended by Dr. Erick Rutto. This program has been instrumental in supporting the Chamber in various regions of Kenya since 2016, including Kirinyaga, Mom-

basa, Nairobi, Uasin Gishu, West Pokot, Vihiga, Embu, and Turkana. The support provided by CIPE includes training, technical assistance, and small grants to help strengthen the Chamber and promote private sector development.

The program has yielded several positive outcomes:

- The program has led to increased engagement and collaboration with County Governments, fostering better relationships and participation in local governance processes.
- There has been a significant increase in proposal development, indicating improved capacity and capability among Chamber members.
- County Governments now regularly consult with the Chamber, recognizing it as a valuable partner in local development.

- The Chamber has actively participated in the development of key legislation such as the Trade and Development Bill and county budget processes, as well as the formulation of County Fiscal Strategy Papers.
- Several chapters have seen a remarkable increase in membership. For instance, Turkana's membership grew from 82 to 300, while Uasin Gishu's membership increased from 600 to 3,700 within three years.
- The chapters have made significant progress in enhancing their governance and management structures.
- The chapters have demonstrated innovation in protecting businesses from the effects of COVID-19, with some of the most innovative

ideas receiving financial rewards.

- Over 300 businesses have received anti-corruption training through the CIPE project, with Mombasa yet to receive this training.
- The program has facilitated 8 Public Private Dialogues with County Governments, fostering cooperation and collaboration.

Dr. Erick Rutto expressed his gratitude to CIPE for their support and encouraged them to continue empowering the Chamber. He also emphasized the importance of private sector partnerships, particularly in addressing food security challenges. Dr. Rutto highlighted the need for the private sector to bridge the 40% gap in the food industry and noted the Chamber's current government support of 30%, underscoring the need for the remaining 70% to come from private sector partnerships.

In his closing remarks, Dr. Rutto pledged his continued support for CIPE and expressed hope for the expansion of the project to other counties in the future. This reflects his commitment to strengthening the Chamber and promoting private sector development in Kenya.



Collaboration between KNCCI and GIZ

The Kenya National Chamber of Commerce & Industry (KNCCI) signed a partnership with GIZ Sustainable Economic Development Cluster in 2021 that saw KNCCI implement two major programs; KNCCI SME accelerator and Covid-19 recovery support program

that supported MSMEs to leverage on a market system development and provide linkages to survive the negative impacts of the Covid-19 pandemic which was implemented in 2022 and KNCCI Women Entrepreneurship for Africa (WE4A) project that aimed to increase market access to at least 63 Women entrepreneurs, alumni of the Tony Elumelu Foundation (TEF) through business networking, investor and B2B match-making. The women entreprenuers were drawn from Nairobi, Kiambu, Nakuru, Kajiado, Garissa, Machakos, Uasin Gishu, Siaya, Kisumu, Nyeri, Busia Kisii, Nyamira, Mombasa and Busia.

To enhance the existing relationship between the two organizations, The Chamber President Dr. Erick Rutto accompanied by the KNCCI Management team and a corporate member Ms. Grace Mbugua Founder Jeillo Collections paid a courtesy visit to Mr. Bernd Lakemeier – Head of Cluster, Sustainable

Economic Development and Youth Employment at GIZ and Ms Irene Omogi – Component Head, Programme for Promotion of Self Employment and Entrepreneurship to deliberate on various areas of collaboration.

The meeting culminated to six major areas of partnership and collaboration. These areas included:



The Chamber President Dr. Erick Rutto accompanied by the Chamber Vice President Mr. Mustafa Ramadhan, KNCCI Kakamega Chairperson Mr. Wycliffe Kibisu, KNCCI Laikipia Vice Chairperson Ms. Lucy Muchoki and KNCCI Management paid a courtesy visit to the Senate Standing Committee on Trade, Industralization and Tourism to deliberate on critical issues affecting the business environment in Kenya especially at the county level.

The meeting was chaired by Kajiado County Senator Hon. Seki Lenku Ole Kanar. A major issue raised was the single business permit. KNCCI advocated for the streamlining of this process to enhance the ease of doing business that would benefit SMEs by reducing the red tape and operational cost.

Policies and legislations affecting the business environment were extensively discussed, highlighting the need for the senate to consider unique challenges faced by these businesses when drafting legislation. A central topic was the current taxation system. The complexity and cumulative burden of multiple taxes and levies were identified as significant barriers. The KNCCI advocated for a simplified taxation system and a more accessible payment processes.

The conversation also focused on improving the competitiveness of Kenyan businesses in the export markets. KNCCI stressed the importance of developing policies and strategies that would enhance value addition, which could make Kenyan goods more competitive internationally.

KNCCI noted the fact that the Kenyan export has been steadily on the decline due to simple home grown challenges that could easily be addressed like high pricing of export certification, duplication of certificates and agencies.

KNCCI also raised the issue affordable credit to SME, pending bills, removal of inter-county trade barriers and unfair competition for SMEs when it comes to dumping, unfair pricing.

On the matter of Devolution Conference, the KNCCI suggested the need to rename the Devolution Conference to "Devolution and trade Conference to incorporate more on Private sector participation.

The meeting underscored the importance of collaboration between KNCCI and the senate Committee in fostering a conducive business environment promoting industrialization, and enhancing SMEs growth. The two parties agreed that KNCCI is an important organization and would be essential in giving their technical expertise once incorporated in the Senate Committee to advise on policies and legislations affecting the business community. It was agreed that KNCCI technical team would be invited to give their input in the following bills:

- Price control essential commodity bill
- Street Vendors Protection bill
- Startup bill
- County licensing uniform procedure bill.

The Chamber President Dr. Erick Rutto represented the private sector as the Chief Guest during this year's celebrations. In his keynote address, He encouraged a South-to-South partnerships that will enhance collaborations in trade and investment, agriculture, ICT, manufacturing, value addition affordable healthcare, tourism, and mineral resources.

He urged the ASEAN bloc to explore opportunities and called for increased efforts to expand and strengthen trade and investment relations with Kenya as she offers a huge market for ASEAN and a gateway to the East African Community, which has a population of close to 300 million, with the entry of DRC.

Kenya-China Partnership Promises 20,000 Textile Jobs in Kilifi and Machakos



In a significant move toward bolstering the local textile industry, a new Memorandum of Understanding (MoU) was inked between the Kenya National Chamber of Commerce & Industry (KNCCI) and the Kenya China Chamber of Commerce & Industry (KCCCI).

This landmark agreement will reinforce trade relations, enhance investments, and notably, generate a whopping 20,000 job opportunities for the youth in the textile sectors in Kilifi and Machakos Counties.


